



Bridal Makeup Agreement

This Bridal Makeup Agreement ("Agreement") is entered into between Makeup by Sherviii, owned and operated by Shervonne Kitto ("Artist") and the Client ("Bride").

By signing this Agreement, the Client agrees to the terms outlined below.

SERVICES PROVIDED

Makeup by Sherviii agrees to provide professional makeup artistry services for the Bride and/or members of the bridal party on the wedding date listed above.

Services may include:

- Bridal makeup application
- Bridal preview/trial (if included in package)
- Bridal party makeup
- False lash application

All services are performed using professional products suitable for long-wear photography and wedding environments.

BOOKING & RETAINER

To reserve the wedding date, a **non-refundable 40% retainer** of the total service amount is required.

Dates are **not held without a signed contract and retainer payment**.

The retainer secures the Artist's availability and compensates the Artist for turning away other bookings.

Because wedding dates cannot be easily rescheduled, the retainer is **non-refundable under any circumstances**.

FINAL PAYMENT

The remaining balance is due 7 days before the wedding date.

If the balance is not paid by the due date:

- Services may be canceled
- The booking may be released
- The retainer will be forfeited

Payments accepted:

- Wix Payments
- Zelle
- Credit Card via invoice

No payments are accepted on the wedding day.

TRAVEL FEES

On-location services include a travel fee.

Travel Fee: \$100

Additional fees may apply for:

- locations over 60 minutes away
- tolls
- parking
- valet fees

Travel fees must be paid with the final balance.

BRIDAL TRIALS

If a bridal preview (trial) is included or scheduled:

- Trials take place at the Artist's studio or agreed location.
- Trials are intended to design the final wedding day look.

The trial appointment includes:

- consultation
- skin assessment

- full makeup application
- adjustments to finalize the look

Trials are non-refundable once completed.

CLIENT RESPONSIBILITIES

To ensure the best results, the Client agrees to the following:

- Arrive with a clean, makeup-free face
- Skin should be properly cared for prior to wedding day
- Inform the Artist of any skin sensitivities or allergies

The Artist is not responsible for reactions due to undisclosed allergies.

SERVICE SCHEDULE

A detailed timeline will be created prior to the wedding.

Clients must be **ready at the scheduled start time.**

If delays occur due to the Client or bridal party:

- services may be shortened
- or certain services may be skipped to stay on schedule

Full payment remains required.

CHANGES TO BOOKING

Changes to the number of services must be made **at least 30 days before the wedding.**

After this point:

- reductions in services will **not reduce the final balance**

Additional services may be added if time permits.

CANCELLATION POLICY

If the Client cancels:

- The retainer is **non-refundable**

If cancellation occurs **within 30 days of the wedding date**, the Client is responsible for **100% of the total contracted amount**.

ARTIST CANCELLATION

In the unlikely event that the Artist cannot perform services due to an emergency, illness, or circumstances beyond their control:

- The Client will receive a **full refund of all payments made**

The Artist will also attempt to help find a replacement artist if possible.

LIABILITY

The Client agrees to hold Makeup by Sherviii harmless from any liability related to:

- allergic reactions
- skin conditions
- sensitivities to products

Clients must disclose any allergies prior to service.

PHOTOGRAPHY RELEASE

The Client grants Makeup by Sherviii permission to photograph and use images of makeup services for:

- portfolio
- website
- social media
- marketing

The Client's personal identifying information will not be shared without consent.

TOUCH UPS

Makeup is designed to last through the wedding ceremony and photography.

Touch-ups during the day may be requested as an **additional service**.

FORCE MAJEURE

Makeup by Sherviii shall not be liable for failure to perform services due to events beyond reasonable control, including:

- natural disasters
 - extreme weather
 - travel restrictions
 - government regulations
